## INVITATION

## I. Technical proposal

The technical proposal shall contain a description of the requirements set out in Terms of references No. 15487, which demonstrates its correspondence with the Bids requirements.

Specification requirements are minimum binding requirements, the offers which do not meet these requirements being rejected as non-compliant.

## II. Financial proposal

The bid form attached will be filled in. The price in the bid form will be developed according to the requirements of technical specification and will be expressed in lei.

The awarding criterion, the lowest price, will apply only to admissible tenders.

In order to award the Service Contract a ranking in ascending order of total price, excluding VAT, will be drawn up following that the offer having the lowest price among the admissible tenders will be declared the winner.

If it is found that there are two or more bids ranked first, the contracting authority will require the re-bidding in a sealed envelope.

There will NOT be accepted alternative offers to the basic bid.

There will NOT be accepted late bids, which will be returned to the sender unopened.

There will NOT be accepted to supplement missing documents, after the opening of bids.

Offers with incomplete applications will be rejected as unacceptable.
